**Terms & Conditions**

- All lessons are to be paid in advance and within 14 days of the date of invoice. Lessons **will not** commence until payment has been received. You can discuss a payment plan with Administration, but it must be agreed before lessons commence.
- If you miss a payment on a payment plan, lessons will be suspended immediately until payments are up-to-date.
- Enrolment is usually required for a minimum of one school term i.e. 10 weeks (unless enrolled on a 5-week trial package).
- A late fee of \$10.00 will be applied to overdue accounts.
- Discontinuing students must give two weeks (2 lessons) notice in writing to ORC Administration.
- You must give the ORC at least 24 hours notice to cancel your lesson. If you fail to provide the appropriate notice, the lesson will be forfeited and the fee is non-refundable. If appropriate notice was provided, a student is entitled to a make-up lesson or a credit will be applied to the subsequent term's invoice.
- The ORC will only provide a **maximum of two make-up lessons/credits per school term** – no refunds will be issued (unless approved by Management), and a request is received in writing.
- Make-up lessons are to be conducted by the end of the first week of the succeeding school holiday period at a time agreed to by teacher and student.
- Costs of Recovery - The debtor/s shall pay for all costs actually incurred by Orange Regional Conservatorium in the recovery of any monies owed under this Agreement including recovery agent costs, repossession costs, location search costs, process server costs and solicitor costs on a solicitor/client basis.
- We will endeavour to always provide you with one tutor throughout your music education however, in some circumstances, tutors may change. We will provide you with due notice if this may be the case.
- A one-off enrolment fee of \$5.00 will be applied to all new individual lesson enrolments, and a \$5 fee for a *Music Practice Diary* which can be collected from ORC Admin after payment.
